You and Me Retreat - 2nd year. We hosted about 60 people representing 30 families affected by childhood cancer for a three-day weekend retreat, enabling parents and children to reconnect.

Kayak Adventure Camp is a camping enthusiast's dream—sleeping on semi-deserted islands, cooking over an open flame, and ocean kayaking several miles a day. It's also a great way to immerse yourself in something greater than yourself knowing the challenge that awaits you is meant to help you grow. This unique camp is designed for young adults aged 18-25 who are themselves pediatric or young adult cancer survivors. In 2020, we had ten campers join us for a one-night, socially distant camping and kayaking trip on Vashon Island.
